Coaching Steps

We recommend a three-step approach as follows:

1

Pre-coaching Needs Assessment

Our initial phone call with you has helped me get a good impression of the need for coaching from your perspective. I typically send new clients a pre-coaching workbook (see attached) and connect in person for the first session. I complete a development plan by the second session.

Successive coaching sessions are designed around the topics as determined by you and your coachee.

A final report and satisfaction survey will complete training to determine how the coaching impacted your coachee, you and the organization.
